# RELEASE OF LIABILITY AND ACCEPTANCE OF DANGERS, RISKS AND HAZARDS

THE STATE OF TEXAS §

KNOW ALL MEN BY THESE PRESENTS:

#### COUNTY OF SHACKELFORD §

That I, the undersigned, for and in consideration for the right to enter and the right to hunt on the real property (the "Land") owned or leased by G. SCOTT SMITH an Individual, with principal offices in Aledo, Texas, and the owners and lessors of the Land, and their respective officers, directors, owners, shareholders, members, agents, employees, sub contractors, affiliates, lessees, and invitees, (hereinafter referred to as the "Released Parties"), and for other good and valuable consideration, including various amenities furnished and to be furnished by me, the receipt and sufficiency of which is hereby acknowledged and confessed, do hereby covenant and agree as follows:

- 1) I HEREBY UNCONDITIONALLY RELEASE, ACQUIT, AND DISCHARGE, THE RELEASED PARTIES, AND EACH OF THEM, FROM ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION,, LOSS, DAMAGE AND INJURY,, RESULTING OR ARISING IN ANY WAY FROM THE USE OF THE LAND, INCLUDING, WITHOUT LIMITATION, INJURIES AND PROPERTY DAMAGE WHILE EN ROUTE TO OR FROM THE LAND, AND INJURIES AND PROPERTY DAMAGE SUSTAINED WHILE LODGED IN FACILITIES FURNISHED FOR MY USE AND THE USE OF OTHER GUESTS BY THE RELEASED PARTIES, OR WHILE ENGAGED IN ACTIVITIES ARRANGED FOR GUESTS BY THE RELEASED PARTIES, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE RELEASED PARTIES, INCLUDING THE SOLE NEGLIGENCE OF THE RELEASED PARTIES, OR ANY OF THEM.
- 2) IN ADDITION, AND FOR THE SAME CONSIDERATION, I HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS THE REASEASED PARTIES, AND EACH OF THEM, FROM ANY CLAIMS, DEMANDS AND CAUSES OF ACTION, FOR LOSS, DAMAGE OR INJURY, INCLUDING PROPERTY DAMAGE AND PERSONAL INJURIES, AND INCLUDING, ATTORNEYS FEES AND LITIGATION EXPENSES, ASSERTED OR CLAIMED BY ME OR BY ANY MEMBER OF MY HUNTING PARTY, GUESTS, INVITEES, OR ANY OTHER PERSON ENTERING THE PROPERTY OF THE RELEASED PARTIES, BY, THROUGH, OR UNDER ME OR BY MY AUTHORITY OR INVITATION, EVEN IF SUCH PROPERTY DAMAGE OR PERSONAL INJURY RESULTS FROM THE RELEASED PARTIES,' OR ANY OF THEIR GUESTS OR INVITEES,' SOLE OR PARTIAL NEGLIGENCE OR GROSS NEGLIGENCE.
- 3) I further agree to pay for all property damages and personal injury damages, caused by me, my employees, agents, invitees or guests, whether negligently, with or without fault, or otherwise, AND TO INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES, FROM ALL CLAIMS, DEMANDS, AND CAUSES OF ACTION, LOSS, DAMAGE AND INJURY, MADE OR SUSTAINED BY ANY AND ALL PERSONS WHOMSOEVER, INCLUDING, WITHOUT LIMITATION, THE RELEASED PARTIES AND THEIR OTHER GUESTS AND INVITEES, AND INCLUDING ATTORNEYS FEES AND LITIGATION EXPENSES, ARISING OUT OF PROPERTY DAMAGE OR PERSONAL INJURY RESULTING FROM THE ACTS OR OMISSIONS OF MYSELF OR ANY GUEST, INVITEE, OR MEMBER OF MY HUNTING PARTY, OR MY AGENTS OR EMPLOYEES, WHETHER OR NOT SUCH ACTS OR OMISSIONS CONSTITUTE NEGLIGENCE OR ARE OTHERWISE ACTIONABLE.
  - 4) The consideration recited herein is contractual in nature, and not a mere recital.

- 5) I hereby further covenant and agree that I, will not make any claim or institute any suit or action at law or in equity against the Released Parties arising from or related in any way to hunting or engaging in any related activities with the Released Parties.
- 6) I understand the risks and dangers of hunting, the use of firearms, and of getting in and out of hunting stands, hunting blinds and motor vehicles, crossing fences, and hunting and shooting in close proximity to other hunters. I also understand that my presence and activities on the Land expose me and my personal property to dangerous conditions, risks, and hazards, including, but not limited to: venomous snakes, insects, and spiders; erosion and general condition of the land, both on and off the roadways, creating rough hazardous and dangerous driving and walking conditions: animals, both wild and domestic, that may be vicious, diseased or otherwise potentially dangerous: water: persons with firearms both on and off the Land, and the use of various types of vehicles, horses, and horse or vehicular drawn wagons. I I EXPRESSLY AND VOLUNTARILY ASSUME ALL SUCH DANGERS, RISKS, AND HAZARDS.
- 7) I agree that the venue for all disputes, demands, claims or suits brought hereunder shall be in Coleman County, Texas. I understand that the Released Parties make no warranties or guarantees, either express or implied, as to the condition of the Land provided for hunting, or to my hunting success.
